ROLE:	To serve as a voting member of the Board of Directors for the Lyon County Historical Society, developing policies, procedures and regulations, monitoring financial performance, and the organization's programs and services.
TERM:	2 years, beginning January 1, 2019 There is a limit of two consecutive terms.

TIME EXPECTATIONS:

- Attend regularly scheduled monthly meetings of the Board of Directors.
- Participate actively in one or more committees of the Board.
- Attend scheduled board retreats, planning meetings, workshops, or other board development activities.
- Attend, support and participate in special organization events.

OBLIGATIONS:

- Fully understand and support the mission of the organization.
- Actively set policy and ensure that the organization has adequate resources to carry out its mission.
- Hire, supervise, and evaluate the Executive Director.
- Monitor the organization's financial performance and legal responsibilities.
- Develop and monitor short and long-range planning and goals.
- Represent the organization to the public and private sector; serve as an advocate for the organization.
- Bring personal and/or professional expertise and that of others to support the mission of the organization.
- Be a LCHS Member in good standing.
- Abide by the Duties of Care, Honestly, and Loyalty.
